BRIEF DESCRIPTION OF THE PROJECT

The Embrace Diversity project was implemented in Rome, Italy, between **April 1, 2021 and March 31, 2022** by the Joel Nafuma Refugee Center (JNRC), in partnership with the nonprofit ItaliaHello Onus and with contributions from the Niwano Peace Foundation.

The project consisted in 6 monthly workshops of one and a half hours each, held at JNRC, attended by students, refugees and religious representatives. Each workshop has been attended by 15 students, 3 refugees and one or more religious leaders and focused on specific geographical areas representative of refugees involved in the project. The aim is to discover the religious and culturally peculiar aspects of such areas and to identify the spiritual principles that belong to each religion which promote solidarity, cooperation, and peaceful coexistence.

The aim of the project is also to raise awareness on the need to include the foreigner and those who have different religious or cultural background.

PROJECT PHASES

- Selection of participants (April-May 2021);
- Assessment and elaboration of content (June-September 2021);
- Implementation of workshops (September 2021-February 2023);
- Online communication campaign launch and delivery (December 2021-March 2022).

PURPOSE OF THE PROJECT

The purpose of this project is to address the hostility towards diversity in terms of culture, religion, ethnicity, which generates marginalization and exclusion and increases the divisions among individuals and communities.

GOAL OF THE PROJECT

The goal of this project is to build a more inclusive, just and peaceful society by strengthening values based on understanding and inclusion of people belonging to different cultural and religious background through dialogue and collaboration.

OUTPUTS OF THE PROJECT

- An **educational program** addressed to high school students, delivered through 6 workshops led by refugees as well as religious leaders.
- An awareness online campaign for digital channels to promote tolerance and acceptance towards diversity in terms of culture and religion.

Phase 1: PARTICIPANTS

In April -May 2021 we identified the participants and assigned active roles as follows:

 Worked as a teacher of English in a private school in Egypt. Country of arrival in Europe, Romania in July 2019 and then Italy in August 2019. Currently working at St George's since September 2020.
- Mr. Cesar Augusto Cuenca, country of origin: Colombia, South America. Computer Science Engineer experienced in project management based on Information Technologies, sysadmin, Helpdesk. Arrived in Italy in January 2020. From January to March, tried to undertake the import export activity of Colombian coffee reaching out to buyers in Italy. Currently working in a horse field doing general service.
- **Mr. Mahamadou Sankareh,** country of origin: Gambia, West Africa. Arrived in Italy: January 2014. Works as a cultural mediator at JNRC since 2016.

One workshop facilitator (JNRC volunteer - English teacher) as follows:

Teacher and educational content creator. Has lived in several countries during his teaching career, including South Korea, Spain and Colombia. Living in Rome since 2018, he serves as Service-Learning Coordinator at the JNRC.

Author and Director of various cultural events. Teacher of visual communication, audiovisual reportage, storytelling, management of large events. In 2013, founder of O.G.M. (Officine Giulia Morello), a network of creatives and artists engaged in social work through projects for institutions, companies and non-profit organizations.

Phase 2: ASSESMENT AND ELABORATION OF CONTENT

From June to September 2021, the project team provided an introduction to the Embrace Diversity project & baseline testing for students to highlight important aspects in relation to migration matters and faith traditions.

The students' level of knowledge on migration matters was tested through a questionnaire as follows:

- Do you know the difference between a migrant, a refugee and an internal displaced person?
- 2. How many refugees do you think there are around the world?
- 3. How many refugees do you think there are in Europe and in Italy?
- 4. Which country hosts the most refugees?
- 5. Which do you think are the main countries refugees come from?
- 6. Which push and pull factors determine migration?
- 7. How is religion connected to conflicts and forced migration?
- 8. In your opinion, are religious principles and religious traditions the same thing?
- 9. Do you think religion (beyond faith traditions) have a role to play in refugee-related issues?
- 10. Would you like to be involved in the development of a communication campaign in order to promote inclusiveness and enhancement of diversity?

After students gained a basic understanding of migration issues and the basic, common principles that inspire different faith traditions, both students and refugees were given guidelines on topics to cover during direct interaction.

Also, religious leaders' intervention was guided through 4 questions which meant to better highlight the shared principles and values despite different faith traditions:

- 1) For a person who embodies your faith, what four words would you use to describe him?
- 2) How would somebody from your faith help somebody else in **need or danger**?
- 3) In your view, what does your religion say about violence towards others and conflicts?
- 4) How would somebody from your religion deal with people with different views to your faith (different religion/cultural background)?

Phase 3: IMPLEMENTATION OF WORKSHOPS

WORKSHOP SCHEDULE (6 sessions)

- 13 October: Opening and Introductory workshop St. George's
- 3 November: 1st workshop, geographic area Afghanistan St. George's
- 17 November: 2nd workshop, geographic area Egypt St. George's
- 1 December: 3rd workshop, geographic area Colombia St. George's
- 15 December: 4th workshop, geographic area Gambia St. George's
- 19 January: closing event JNRC

OPENING AND INTRODUCTORY WORKSHOP

The first Workshop on October 13th, 2021 involved all of the participants in the project and was held at St. George's British International School.

Students, refugees and religious leaders discussed on how all religious value systems embrace humanity, caring and respect, and the tradition of granting protection to those in danger. And on how the principles of **modern refugee law** have their oldest roots in these ancient texts and traditions.

It was highlighted that the call to "welcome the stranger" through protection and hospitality, as well as treating all people of other faiths and backgrounds with respect and equality are practices that are firmly rooted in every religion. However, we witness every day persecutions, violence, wars often waged with the banner of defending religious principles.

Based on newspaper/website articles about a historic/current event that challenges the principles, participants discussed about 3 study cases and religious leaders provided explanations on how it is possible for conflicts to arise in the name of religion.

The 3 study cases which have been discussed, are as follows:

- Instability in Myanmar.
- The Taliban's return in Afghanistan and women's condition.
- Northern Ireland still divided by peace walls 20 years after conflict.

FOUR CONSECUTIVE THEMED WORKSHOPS

From November until December 2021, we carried out themed workshops where students, along with one or more refugees from a specific geographic area, explored the principles we should all live by, and shared examples of when we fall short. Each refugee shared its own experience based on specific guidelines.

The outline of each of the 4 workshops was pretty much the same while the geographical area under consideration was from time to time different and related to the host refugee.

Topics were addressed and discussed according to guidelines as follows:

What are the key principles?

- 1. What are the principles that we should all live by?
- 2. Give examples of where we do/do not live by these principles in our daily life
- 3. Why do we not live by these views?

First-hand experience provided by each refugee:

LEAVING THE COUNTRY

- 4. How discrimination in country-of-origin may lead people to wanting to leave (diversity within the country is not embraced, but used to discriminate)
- 5. Challenges during the journey, determined by discrimination.

ARRIVING AND LIVING HERE IN ROME

- 6. How being different here in Rome makes it difficult for people to be accepted
 - a. Refugees Experience
 - b. Students' experiences (what they have heard/seen)
- 7. What are the **fears** of residents here in Italy that fuels this experience?

HOW TO ADDRESS THE PROBLEMS THAT AROSE THROUGH THE DIALOGUE

- 8. From the refugee's experience what would have made a difference to them settling here in Italy
- 9. How can we make a difference?
 - a. How can we convince others to change their perceptions?
 - b. Identification of key factors for planning the awareness campaign
 - c. Production and collection of digital materials for awareness campaign planning

Phase 4: ONLINE COMMUNICATION CAMPAIGN - LAUNCH AND DELIVERY

Starting from the reflections emerged during the workshops with students, religious leaders and refugees, ItaliaHello, project's partner, developed an online communication campaign that was promoted on ItaliaHello and JNRC's social networks (Facebook and IG).

Online content consists of short videos, interviews, pictures and testimonies of participants created by a professional video maker with the support of a communication expert. The communication team participated in each workshop and worked together with students and refugees to identify the format and language best suited to the visibility and dissemination of the project.

3 interviews with religious leaders and 3 interviews with refugees were carried out on the themes of:

- Inter-religious understanding on diversity and peace
- Direct experience of refugees during their travel and stay in Italy

All of this content was published and promoted online and offline between October and December 2021. At the same time, the team worked with the students to outline, through group activities and role-playing games, the final message to be transmitted online to their peers on diversity, on how it is perceived by various cultures and the difficulties that can be encountered in daily life.

Through Storytelling workshops, the claim was identified: 'what diversity is for me, and how can I welcome others in my daily life.

Each student provided their own testimony and a short spot was created. It was officially released online in March 2022. The spot was conceived and developed with the active contribution of the students with the aim of promoting a peer to-peer communication model.

At the end of the activities, another additional video was made, initially not included in the project proposal, to tell the objectives, activities and expected results. The video was made in both Italian and English to reach a wider audience.
